Requirements for Applicants Who Wish to Apply For
Endorsements to Current Level II (Advanced) and Level
III (Senior) Certification.

Applicants for Inspector Supervisor must:

- ▶ Hold a **current** Level II (Advanced) or Level III (Senior) Inspector Certification.
- ▶ Have supervisory responsibilities for amusement ride inspectors.
- ▶ Attend a minimum of twenty four (24) hours of formal education on management or management related issues.
- ▶ Be approved by the Examination Board.

Applicants for Instructor must:

- ▶ Hold a **current** Level II (Advanced) or Level III (Senior) Inspector Certification.
- ▶ Attend a minimum of sixteen (16) hours of formal education on how to conduct training or perform a minimum of sixteen (16) hours of formal instruction at an accredited amusement ride safety training program.
- ▶ Be approved by the Examination Board.
